Job Description

Summary of Post Function

This post involves interviewing member of the public in their own homes, on-street or other public places. Most work will be conducted within the Gypsy and Travelling community with interviews taking place and other relevant information being collected on sites.

ORS projects are typically undertaken on behalf of public sector clients including local authorities, housing associations and national or regional government, and topics studied include local housing, health, employment, policing, and satisfaction with services provided. The information gathered is analysed and reported at an aggregate level and is only used for the purposes of the study.

The post-holder will usually be expected to work independently, but will need to be able to work as part of a broader team of interviewers and supervisors, and also liaise with management and other support staff. Excellent communication skills are required as the post-holder must be able to build a rapport with members of the public, including the Gypsy and Travelling community, during detailed personal interviews to gain their confidence to discuss sensitive issues such as family and financial circumstances. Introductory and on-going training will be provided.

Some surveys may require Non-Police Personnel Vetting (NPPV) clearance before work can be allocated.

For each new project or type of project, you should expect a briefing and clear instructions regarding the data collection requirement. The nature of the work means most projects require the same data and use a standardised pro-forma.

- Undertaking interviews with respondents in person
- Recording data from interviews to the ORS systems
- Having regard for ORS' quality and information security policies and procedures
